- Items may have quantity limits.
- Prices are subject to change.
- If your item is not in stock, an item of similar or greater value may be shipped in its place.
- Return policy
 - Returns or exchanges are not allowed, due to the personal nature of products. Please call the number listed in our catalog within 30 days of placing your order if:
 - You haven't received your order.
 - You received a defective or damaged item.

- There is no dollar minimum on orders when shopping retail stores.
- Taxes apply at retail stores.
- If your account balance does not cover your total, you can still get the item. You will be responsible for any payment over the allowed amount.
- Use your OTC/Healthy Food debit card when checking out, or if you have the mobile app and set up your account, you can use the digital card in your mobile app.
- To check if an item is covered by your benefit, you can scan the bar code on the product in the Healthy Benefits app and a message will appear to inform you if it is covered.
